Datuk Dr. Abdul Raman Saad holds an honours degree in Law from the University of Singapore in 1974 and a Masters degree in Law (with specialization in Electronic Law) from the University of Melbourne in 2004. In the year 2006, he obtained a Doctorate degree in Business Administration from University of MW. Missouri, USA.

He had served the Malaysian Judicial and Legal Service from 1974 for four and a half years in the various capacities as Magistrate, Deputy Public Prosecutor/Federal Counsel and Assistant Director of Legal Aid, Malaysia before he embarked into private legal practice in 1978.

He has over 30 years of experience in legal practice, covering diverse matters such as in real estate, corporate and commercial laws, restructuring, corporate banking and finance, Islamic finance and sukuk, merger and acquisition and privatisation. He also advises on issues in Personal Data Protection and Cyber Security laws in Malaysia.

Datuk Dr. Raman is an active speaker and has presented many papers at law conferences both at national and the international levels in the area of Personal Data Protection, Cyber Security and Islamic finance.

He has authored a book entitled "**Personal Data Privacy Protection**" published by Lexis Nexis/Malayan Law Journal in 2005

Currently, he is a director of Technical University Malaysia Melaka (Universiti Teknikal Malaysia Melaka - UTEM), a public funded university and a director of CyberSecurity Malaysia that exists as the national reference and specialist centre in cyber security under the purview of the Ministry of Science, Technology and Innovation (MOSTI) with its objective, amongst others of addressing computer security issues amongst Malaysian internet users.
