Tournament Format Rules

- 1. There will be Maximum of 8 teams.
- 2. Teams will be divided into 2 groups.
- 3. 2 Top of the group are going to the next stage (semifinal, 3rd placing & Grand Finale)
- 4. 3rd & 4th of the group are going to the next PLATE stage (semiPlate, 3rd placing & PlateFinale)
- 5. 7 minutes each half 1 minute break.
- 6. Each team consists of 7 players 5 players 2 reserve.

(100% lawyers & law firm staffs & for invitational teams 100% staffs of respective body)

- 6.1 Non-compliance of the clauses will be deemed as non-competence to register.
- 6.2 Any frauds will be subjected to **DISQUALIFICATION**
- 6.3 There will be **VERIFICATION OF PLAYERS PROCESS** before KICK OFF. **ALL PLAYERS SHALL BRING IDENTITY CARD and/or PASSPORT** before kick-off to be verified by the Competition Committee
- 6.4 The process starts at 1.30 pm of the respective day by the **Tournament Committee.**
- 7. Registration will be closed on 8th of April 2017.

General Match Rules and Regulations

- 1. All teams must be on standby at their court of play 10 minutes before the start of each of their matches.
- 2. If a team is more than 2 minutes late for the start of their game, i.e, it does not have a minimum of players on court ready to play, that team will be disqualified and the opposing team who is not in default of this rule will be awarded a walkover with the score of 2-0.
- 3. After the start of the game, a team with less than 4 players on the court (whether caused by injury or any reason) will be disqualified and the opposing team will be awarded a walkover with the score of 2-0.
- 4. The ball will be deemed to be out of play when it has fully crossed the outline of the court or hits the roof of the court.
- 5. A kick will be awarded to the opposing team when the ball is deemed to be out of play.
- 6. Players are not allowed to score directly from a kick in.
- 7. Players must not take more than 5 seconds to take the kick in, failing which the kick in is awarded to the opposing team.
- 8. Defending players must stand at least 3 feet away from a player that is taking a kick in, corner or free kick.
- 9. All players are allowed in either penalty areas.
- 10. Goalkeepers are not allowed to handle back passes from teammates.
- 11. If a goalkeeper handles a back pass from his teammate, the opposing team will be awarded a one step penalty kick.

- 12. During a one step penalty kick, the goalkeeper will not be allowed to move forward from the goal line at all times.
- 13. Players are allowed to score a goal directly from corner kicks.
- 14. Slide tackles are not allowed. The referee has full discretion in determining the legality of the challenge.
- 15. For any foul committed by a team in its penalty box, the opposing team will be awarded a penalty.
- 16. Players are allowed to score goals directly from the centre circle kick-off.
- 17. Time will be stopped for injuries.
- 18. All Substitutions are "rolling substitutions" i.e the referee will not stop the game for substitutions.
- 19. Players will be able to score from anywhere in open play.
- 20. 3 points are awarded for a win, 1 point for a draw and 0 points for a loss.
- 21. If 2 or more teams are tied on points at the end of their round robin group stage, their position will be determined by goal difference between the teams' respective goals scored and goals conceded, and if that still results in a tie, the higher number of goals scored, and if the result is still a tie, penalty will conducted.
- 22. The Johore Bar Sports Committee shall have absolute discretion to amend any rules at any time.
- 23. Referees' and the Johore Bar Sports Committee's & Competition committee decisions shall be final and there will be no recourse to appeal their decisions.

Disciplinary Rules

- 24. The referee may in his discretion award a yellow or red card for any unsporting conduct, dissent, and/or violent play as he deems fit.
- 25. -2 yellow cards* one match ban

Red card – one match ban Red for violent conduct – tournament ban *cumulative throughout the tournament.

- 26. Yellow cards will be flushed out at the semi final stage. 2 yellow cards during a match will warrant a red card where the player to whom the card is shown has to leave the pitch immediately.(if any)
- 27. Should a player or a team show any dissent or gross unsporting behaviour towards an opponent, a referee of the organizing committee, e.g abusive language, aggressive behaviour, making threats, fighting etc. (this category is not limited), the referee/s and/or organizing committee shall the discretion to disqualify the player or his/her team for further participation in the competition.
