## **3. MOTIONS**

The following motions were passed by the House :

### **Motion No. 1**

- 1) The Johore Bar abhors and rejects any suggestion that any of its leaders elected at an AGM cannot be removed by members at an EGM properly convened before the expiry of his or her term of office.
- 2) The Johore Bar commends its outgoing Chairman (S. Balarajah), its outgoing Committee Members (namely Kuthubul Zaman, S. Gunasegaran, Gurcharanpal Singh, Puan Shahareen Begum Binti Abdul Subhan, Tho Kam Chew, Puan Norhayati Bte Mohamed, Kuna Nadasen, R. Jayabalan, Mohd Nor Bin Zabidin, and Cik Iza Dora Binti Md Hanipah), and its outgoing Honorary Secretary (Ms Tay Bee Choo) for having answered the call to serve the Bar in midstream so that the Johore Bar would not be left in the lurch and would not be deprived of good and legitimate leadership; and further for their dedication in continuing to serve the Bar notwithstanding the added burden of resisting a suit.
- 3) The Johore Bar upholds the principle that, where choices of leadership are concerned, members voting at a general meeting (whether AGM or EGM) constitute the highest decision-making body of the Johore Bar. The Johore Bar firmly rejects any claim or assertion by anyone to the contrary.
