FEEDBACK ON PROBLEMS FACED BY MEMBERS IN COURT

I refer to the Chairman's message to the members of the Johore Bar vide Circular No: 3/11.

Taking up his call to help reduce, if not eliminate, the hardships occasioned by the KPI and Tracking systems, this circular is issued with the purpose of addressing court problems, if any, faced by members in courts in the northern Johore jurisdiction.

To this end, the Northern Johore Affairs Sub-Committee is in the process of compiling information to furnish to the authorities concerned. For this purpose, a form is attached for your use.
